The seminar was attended by 140 members and many came in from outside the metro area. In fact, quite a few drove in from Wisconsin for the meeting. As I understand, Wisconsin has also organized a Ground Water Association, good luck to our neighbors. I would like to congratulate the people in Wisconsin for their excellent ground water slide show and public service announcements presenting their theme "Ground Water: Wisconsin's Buried Treasure." Making a twenty minute film or a good show of 40 slides is expensive, but the expense is warranted when you think of how often the topic of ground water is mentioned by the news media. I think the MGWA should strongly emphasize public education as part of its objective. How about some comments and help on this.

This November our program will be Dr. Tom Winter who many of you will recognize from his work on ground and lake water interactions, details of the meeting are inside. I have also discussed with several other members another summer seminar. The topic would be on ground water quality monitoring. The program would look at problems from well installation to the lab analysis, and possibly the legal problems of using the final data. This is not just limited to our quarterly meetings; as I mentioned before, educational programs are needed.

#### MGWA Public Education Committee

The Public Education Committee is putting together educational materials that will be made available to the general public in the near future. The Committee has on hand or has ordered the following: a slide presentation, grade school curriculum guide, and other printed material from the Wisconsin DNR, brochures from NWWA, a slide presentation produced by the New England Water Pollution Control Council, and a list of films currently available for rent or purchase. In the coming months the goals of the Committee are to review some of the available films and recommend to the MGWA Board the films which should be purchased, if any; to design a brochure describing the Minnesota Ground Water Association; to develop simple, effective demonstration materials to use when explaining the principles of ground water flow, occurrence and pollution; to meet with the Environmental Board and other appropriate groups to determine what the role of an organization such as the MGWA should be. At this time, we hope to be able to offer educational materials and - as often as possible - speakers, to interested groups.

One of the benefits of a professional organization like the Ground Water Association is that it gives members an opportunity to represent their profession out in the community, to provide accurate information to concerned people, and to encourage young people to enter the profession.





## FALL 1983 MEETING

- <u>WHAT:</u> MGWA Fall 1983 Meeting. A short business meeting will precede a presentation/discussion about "The Why's, Wherefore's, How's, and I-Told-You-So's of Piezometer Installations". This meeting will jointly sponsored with the Minnesota Section, AWRA.
- WHO: Dr. Tom Winter, Research Hydrologist with the USGS in Denver and former Minnesotan, will discuss his research undertaken on the appropriate techniques for constructing, installing, and measuring piezometers to insure precise and accurate hydraulic head determinations.
- <u>WHEN:</u> Wednesday evening at 7:30pm, Novermer 16, 1983-the week before Thanksgiving.
- WHERE: The auditorium of the St. Paul Area Vocational-Technical Institute, 235 Marshall Avenue, St. Paul (maps enclosed). The Institute is located between the St. Paul Cathedral and I-94 by the State Capitol. Offstreet parking (free) is available in a lot west of the building on Marshall (a one-way street); enter building from Marshall Ave., and follow signs to the Auditorium.



#### MGWA GROUNDWATER MODELING COURSE

The Minnesota Ground Water Association is co-sponsoring with the University of Minnesota Continuing Education Extension a short seminar on groundwater modeling. This course will cover the basic methods of groundwater modeling with an emphasis on computer applications. The course will try to provide those attending with an understanding of the mathematical bases for groundwater models and familiarize them with the analytical, finite difference, and finite element methods that are often used for groundwater modeling. Several regional groundwater models based upon these methods will be presented and applied and several applications of these methods demonstrated in the course. This seminar will take three days.

In addition, an additional two-day seminar will follow for those interested in learning more about advanced analytical models. This will be devoted to detailed discussion of advanced analytical elements and the applications in computer models. Detailed lecture notes will be provided for both courses.

Arrangements for the modeling course are still underway. However, the course is expected to be offered in February at a very reasonable cost. The course will be taught be Drs. Otto D.L. Strack and Henk Haitjema and other members of the Department of Civil and Mineral Engineering at the University of Minnesota. More information will be provided in the future to the MGWA members.

#### MPCA

The Minnesota Pollution Control Agency has three publications available dealing with ground water in Minnesota:

- Procedures for Ground Water Monitoring: Minnesota Pollution Control Agency Guidelines
- Ground Water Quality Monitoring Program: Analytical Data for 1982 and Principal Aquifer Analysis

Ground Water Protection Strategy Framework for Minnesota

<u>Procedures for Ground Water Monitoring</u> will remain in draft form until August, 1984, during which time comments will be received from its users. <u>Ground Water</u> <u>Quality Monitoring Program</u> is the fifth in a series of documents describing the ambient quality of Minnesota's ground water. <u>Ground Water Protection Strategy</u> <u>Framework</u> is the final report to the U.S. EPA resulting from a 29-month grant to the agency under Section 208 of the Clean Water Act. #### Citizens League Study

The Citizens League is forming a study committee to conduct research on the topic of <u>Ground Water Supply and Quality</u>. The committee will suggest an organizational framework for management and accountability in Minnesota's ground water supply, recognizing the interaction between quality and supply, and assuming that in coming years demand for this resource will exceed its availability. The study will get underway in early 1984.

The policy of the League is that committee members should be members of the League. The Citizens League, a non-partisan, public affairs group, does research and education in the St. Paul-Minneapolis metropolitan area. For information, call the League's office 612/338-0791.

#### Water Planning Board, EQB, merged

After four years of debate, the Legislature has created the permanent water resources coordinating body recommended in the Water Planning Board's 1979 framework water plan. The Water Planning Board and the Southern Minnesota Rivers Basin Board were merged with the state Environmental Quality Board to form the recommended organization in Laws 1983, Chapter 301. The Legislature expects that there will be a stronger link between planning for environmental protection and natural resource use and the adoption of state policies. #### Superfund Update

The MPCA Board has approved \$50,000 for use at the Isanti solvent siteto provide a permanent clean drinking water supply for 3 families; \$250,000 to clean up above-ground arsenic sites in the state; and \$100,000 for remedial investigations of below-ground arsenic sites (excluding Perham, Wadena and Morris). The \$250,000 for above-ground arsenic cleanup is the Agency's first use of the State Superfund. Part of the money will be used for a publicity program to encourage citizens to report above-ground arsenic storage sites in addition to the 50 sites reported thus far.

## National Water Well Association/Technical Division

Illinois and Wisconsin join Minnesota in forming state Associations. The first meeting of the Illinois Groundwater Association was held in Morris on June 1, 1983. An enthusiastic group of 81 people attended the afternoon and evening meeting. One of the speakers was Tom Johnson of the Illinois Geological Survey who was the guest speaker at the first MGWA membership meeting one year ago. In Wisconsin, the organizational work is well underway. Bob Brobst and Gary Kulibert, MGWA members from Wisconsin, attended the August seminar and discussed their plans for the Wisconsin organization with MGWA members. They expect to hold a membership meeting in the near future.

NWWA has expressed some interest in holding a regional conference in the Twin Cities. MGWA members who feel that we are long overdue for a conference may want to write to the NWWA Planning and Management Committee (500 West Wilson Bridge Road, Worthington Ohio 43085) to encourage our parent organization to schedule a Twin Cities conference in the near future.

#### American Geophysical Union/Hydrology Section

The journal <u>Water Resources Research</u> will begin monthly rather than bimonthly publication in January 1984. In addition to this change, the Hydrology Section Executive Committee is considering developing a new journal to serve the more practically oriented members of the Section. The Committee welcomes written comments on whether such a journal is needed.

A Hydrology Section Committee on the History and Heritage of Hydrology has been formed. The Committee plans to write up its purposes and goals in an article for <u>Eos</u> and the schedule some History of Hydrology sessions, probably for the Fall 1984 and/or Spring 1985 Meetings.


