Financial Update – Kara

Gibanski down \$18.8k this quarter, down \$18.8K (-6.90%) YTD.

Total endowment down \$23.6K this quarter, down \$23.6K YTD.

Kara: Rough quarter, as expected. All accounts are down but the performance of each account beat the DOW and S&P 500 over the quarter.

Two undergraduate, Anna Klein and Andrew Vierbicher, and two graduate students, Brad Evraets and Philip Margrite were selected by the scholarship committee for \$1,500 scholarships.

Additional award-

An additional applicant stood out this year who clearly took a nonstandard path toward finishing her degree, but through adversity finished a hydro degree and is now a grad student at the U of MN. Her essay is heartfelt, she has financial needs and hopes to share her knowledge to address water resource problems with the tribes. June Sayers stood out and the committee suggests funding a 5th scholarship. None of the board sees any issue with adding a 5th scholarship this year.

Kara motions to award 5 scholarships of \$1,500, Eric seconds the motion. Approved unanimously.

Action Items:

Julia will prepare scholarship award letters for the 5 winners and those that didn't receive an award. Julia will communicate with Jennie to get checks for the direct payments that will go out in the award letters.

Award winners will also be invited to the spring conference. Tony will talk with the incoming MGWA president about introducing the award winners at the spring conference.

The Scholarship Committee will contact The Newsletter Committee and suggest the newsletter host a feature on the award winners.

The Scholarship Committee will discuss scholarship process with DEI committee in order to better capture ways to better support non-traditional or BIPOC students.

MGWA Update – Tony

The MGWA is preparing for the virtual spring conference. The goal is to have speakers that give statewide coverage of the Minnesota DNR groundwater provinces.

The University will no longer allow the MGWA to rent the conference room as the MGWA is not associated with the University. The MGS may be able to sponsor the reservation of the conference room.

The fall 2022 conference is the 40th anniversary conference of the MGWA. The hope is to have an in-person conference, or at least a hybrid event.
